Terms and Conditions of Consultancy Services

Definitions

Travel Consultant: The individual or entity providing consultancy services. Client: The individual or company engaging the travel consultancy services. Services: The travel consultation, planning, and advisory services provided.

Services Provided

Expedition Peru will provide services including, but not limited to, travel itinerary planning, accommodation, transportation, activity and general travel advice for Peru.

Duration and Termination

The services will be provided in accordance with the fee structure outlined above. For the consultancy service the client with pay for the time and expertise of Expedition Peru's travel advisors and consultants. A client can pay for the service and the time period paid for will be available for use within 60 days of purchase. Any unused time cannot be refunded.

Fees and Payment
